Hospira, a Pfizer company, is committed to providing information on supply issues so that appropriate contingency plans can be made to facilitate patient care and safety.

We want to provide an early alert on our Aminosyn line of products. Hospira is allocating shipments to last throughout 2016 to avoid a stock out. This supply interruption is due to a manufacturing delay. **We recommend consideration of prioritizing where Aminosyn products are the only choice for the patient's treatment.** Please consider alternative products where clinically applicable.
