Impacts of the Infant Formula Shortage: The Health Care Provider's Perspective

Event Overview

The infant formula shortage national crisis has demonstrated the fragility of the nutrition supply chain impacting infant health and outcomes. A discussion moderated by ByHeart's Chief Medical Officer Dr. Devon Kuehn, panelists Drs. Mark Corkins, MD, CNSC, FASPEN, AGAF, FAAP, Ruba Abdelhadi, MD, CNSC, NASPGHAN-F, and Allison Blackmer, PharmD, BCPS, BCPPS, FCCP, FASPEN discussed:

- Preliminary findings from a recent national survey on the impacts of the formula shortage on healthcare providers and their patients
- Resources developed and advocacy efforts already in place by key pediatric and nutrition societies to ensure access to nutrition products for infants and children
