## Dear Valued Customer,

At Baxter, our goal is to help you ensure continuity in patient care through reliable, consistent product supply. Currently, we are experiencing unprecedented demand for our Amino Acid and Clinimix Injections. We have substantially increased our production to accommodate for this unforeseen demand. In the meantime, we will be placing the following codes on protective allocation effective the date of this letter. Please see Table A for the codes affected and allocation limits for direct customers and wholesalers/distributors.
